



# **Aperam Austenitic Stainless Steel 316/316L/316Ti Tubes 2B/2D**

## 1 Declaration of General Information

This LCA management summary is intended for external communication by Aperam for their Austenitic Stainless Steel 316/316L/316Ti Tubes 2B/2D. This document is based on the EPD guidelines listed in prEN 17662:2021 and EN 15804:2012+A2:2019. It can be considered as a light version of a formal EPD.

Aperam Austenitic Stainless Steel 316/316L/316Ti Tubes 2B/2D are produced by Aperam at Aperam Châtelet, Aperam Genk, Aperam Isbergues and Aperam Usti. This LCA management summary covers the environmental impact of production at Aperam, transport and assembly as well as end-of-life processing. The results are listed per 1 ton of steel.
